## For Immediate Release: Loudoun County Firefighters Participate in 2017 Toys for Tots Campaign

The Loudoun County Fire and Rescue System and the Loudoun Career Fire Fighters Association are pleased to announce their participation in the 70<sup>th</sup> Annual Toys for Tots Campaign, sponsored by the United States Marine Corps Reserve. “The department is proud to once again participate in this wonderful program,” states System Chief W. Keith Brower, Jr. “Your generosity will help put smiles on the faces of many children this holiday season.”

The Toys for Tots Campaign began in 1947 when a group of U.S. Marine Reservists collected and distributed 5,000 toys to needy children in the Los Angeles area at Christmas. In 2016, the Marine Toys for Tots Program collected and distributed 18 million toys to 7 million less fortunate children who might not have otherwise experienced the magic of the Christmas holiday season.
