S. Navy Chaplain and have earned the FMF Badge serving with Marines; If discharged, I am in receipt of a DD Form 214 or a Certificate of Discharge indicating "Honorable Service". ("Honorable Service" will be defined by the last DD Form214 or Certificate of Discharge that the applicant received). General Discharge under Honorable Conditions is acceptable
